**Hamamatsu Photonics K.K. announces Introduction of the Executive Officer System, Appointment of Executive Officers (Planned) , and Nomination of Candidates for the Director/Audit and Supervisory Board Members**

As of today's date, the Board of Directors has resolved to submit for approval the following Introduction of the Executive Officer System, Appointment of Executive Officers(Planned), and Nomination of Candidates for the Director/Audit and Supervisory Board Members of the company to the Ordinary General Meeting of Shareholders of Hamamatsu Photonics K.K., to be held in December 18, 2020.

1. Reason for Introduction of the Executive Officer System

Hamamatsu Photonics K.K. will separate the business execution function from the "Board of Directors", which is responsible to both decision making and supervision of business execution, and clarify the roll of the "Board of Directors Meeting", and delegate the authority of business execution to "Executive Officers". Through these measures, we will aim to strengthen our corporate governance system and business execution system, and make flexible decision making.

2. Outline of the Executive Officer System

- (1) The appointment and discharge of Executive Officers shall be decided by resolutions in the Board of Directors Meeting.
- (2) The terms of office of Executive Officers shall be two years.
- (3) The business operations of Executive Officers are decided by the Board of Directors Meeting and Executive Officers execute them under the supervision of the Board of Directors Meeting.
